Sealed Bids for the construction of the Abbeville 2022 Emergency Power Improvements – CWSRF No. CS010261-06 will be received by The Water Works and Sewer Board of the City of Abbeville at the Abbeville City Hall Council Chambers, 101 E. Washington St., Abbeville, Alabama 36310, until 10:00 a.m. local time on Wednesday, September 18, 2024, at which time the Bids received will be publicly opened and read. The Project consists of installation of one new standby generator and replacement of an existing generator at the South Lagoon Wastewater Treatment Facility, and purchasing a trailer mounted generator that can be use at the three system pumping stations and installing receptacles and transfer switches at those stations compatible with the generator.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and/or unit price basis as indicated in the Bid Form.

Prospective Bidders are urged to register with the designated website as a plan holder, even if Bidding Documents are obtained from a plan room or source other than the designated website in either electronic or paper format. The designated website will be updated periodically with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated website.

Prospective Bidders may obtain or examine the Bidding Documents at the Issuing Office on Monday through Thursday between the hours of 8:00 a.m. to 5:00 p.m. and on Friday between the hours of 8:00 a.m. to 12 noon, and may obtain copies of the Bidding Documents from the Issuing Office as described below. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bidding Documents also may be examined at the Abbeville City Hall, 101 E. Washington St., Abbeville, AL 36310, on Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m., local time.

Printed copies of the Bidding Documents may be obtained from the Issuing Office by paying a deposit of \$120.00 for each set plus shipping as applicable. Bidders who return full sets of the Bidding Documents in good condition within 10 days after receipt of Bids will receive a full refund minus shipping charges. Non-Bidders, and Bidders who obtain more than one set of the Bidding Documents, will receive a refund less the cost of printing, reproduction, handling, and distribution for documents returned in good condition within the time limit indicated above.

No Bidding Documents will be issued within 72 hours of the scheduled date and time of the Bid Opening.

Bid security shall be furnished in accordance with the Instructions to Bidders.

All Bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or Bid will not be received or considered by the Owner. The

Bidder shall show evidence by including its current license number during registration and clearly displaying on the outside of the sealed envelope in which the Bid is delivered.

The Owner reserves the right to reject any and all Bids and to waive technical errors if, in the Owner's judgment, the best interest of the Owner will thereby be promoted. The Owner further reserves the right to negotiate price and time with the low bidder.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.
