

ARTICLE 3 – BASIS OF BID

3.01 *Lump Sum and Unit Price Bids*

- A. Bidder shall not include in the prices bid the sales and use tax on products which are exempt from sales and use tax.
- B. Bidder will complete the Work in accordance with the Contract Documents for the following lump sum (stipulated) price(s), together with any Unit Prices:
